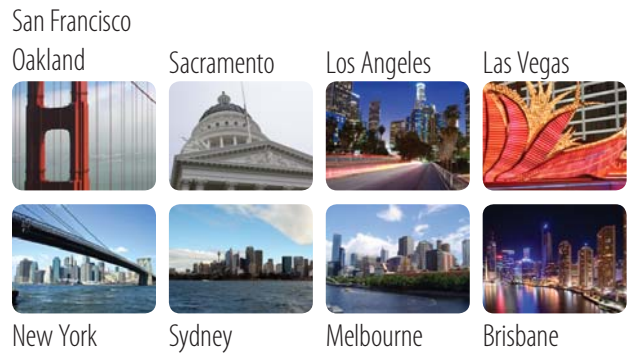

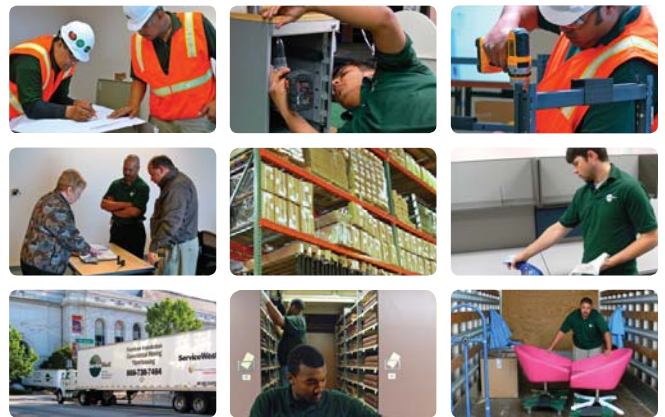

Adjustments (both up and down) to the contract labor rates applicable to the SCA will be in accordance with clause 52.222-43 Fair Labor Standards Act—Price Adjustments (Multiple Year and Option Contracts).
